Mulch is available at the Indianola Brush Facility during normal hours of operation free of charge. Individuals wanting mulch will need to provide their own containers and assistance is not normally provided except on the second Saturday of the month.

On the second Saturday of the month from 9:00 am - 12:00 pm assistance for loading pick-ups and/or trailers is provided for a fee of \$10.00 per load. The fee helps to off-set equipment and personnel expense.

Crushed Concrete

On the second Saturday of the month the Indianola Brush Facility has crushed concrete available for \$10.00 per ton. Employees will be available from 9:00 a.m. - Noon to load pick-ups, trailers and truck with recycled concrete material.
