**Subject:** Current Projects Update

The purpose of this memorandum is to provide a brief synopsis of different projects that may be of interest to the Council. Of the 17 projects listed, one (1) is awaiting a submittal from the developer, ten (10) are in review, and six (6) have been approved and are in construction. All dates are 2021, unless noted otherwise.

# 1. Cavitt Creek Condominiums (1400 and 1500 blocks of North 9th Street)

#### **Status: Review**

- Site plan for Cavitt Creek Condominiums I, which proposes one (1) single-family unit and eight (8) two-family units, was submitted on May 20
- Site plan for Cavitt Creek Condominiums II, which proposes one (1) single-family unit, 20 two-family units and 13 multi-family units (six-plexs), was submitted on May 20

## 2. Phillips Floor (1605 North 9<sup>th</sup> Street)

## **Status: Review**

- Site plan and building permit submitted on May 3
- Site plan review comments returned on May 13
- Updated site plan submitted on May 24

## 3. Des Moines Metro Opera Warehouse (1909 North 14th Street)

## **Status: Review**

- o Site plan submitted on April 8 for a building addition
- Review comments returned to applicant on April 28
- Revised site plan submitted on May 11
- Review comments returned on May 26

## 4. DeYarman Ford (2406 North Jefferson Way)

## **Status: Review**

- Partial site plan submitted for building renovation on February 18
- Alternate site plan for building elevations was approved by the City Council on March 23
- Minor subdivision plat was submitted on March 3
- City Council approved plat on April 19
- Site plan submitted on May 14
- Site plan review comments returned on May 26

# 5. All Creatures Small (2400 West 2<sup>nd</sup> Avenue)

## **Status: Review**

- Addition to the existing facility
- Site Plan/Stormwater Management Plan submitted on January 25
- Site Plan/Stormwater Management Plan comments returned on February 4
- o Revised site plan received on February 26
- o Site Plan/Stormwater Management Plan comments returned on April 28

## 6. Vice Construction (2500 West 2<sup>nd</sup> Avenue)

## **Status: Construction**

- o The City Council approved an alternate site plan of October 19, 2020
- o Building Permit submitted on November 3, 2020
- o Variance for total height approved by the Board of Adjustment on November 4, 2020
- A second alternate site plan approved by the City Council on November 16, 2020
- o Site plan approved on November 17, 2020
- Full building permit issued on February 4

# 7. Williams Terrace (1600 Block of North 9th Street)

## **STATUS: Review**

- Developer hosted a neighborhood meeting on March 9, 2020
- o Rezoning petition received on April 6, 2020
- The Planning and Zoning Commission reviewed the rezoning request at its April 21, 2020 meeting
- The City Council approved the rezoning request on July 6, 2020
- Planning and Zoning Commission reviewed final plat on January 12
- o City Council approved the final plat on January 19
- Building permit application/plans received on February 26
- o Site Plan submitted on March 26
- Site plan reviewed by the Planning and Zoning Commission on April 13
- Easement vacation application submitted on May 18
- Updated site plan submitted on May 21

## 8. People Bank Administration Building (500 East Iowa Avenue)

#### **STATUS: Construction**

- Site plan and building permit submitted on March 13, 2020
- Site plan approved on April 17, 2020
- o Building permit issued on April 17, 2020
- Final inspection conducted on January 8
- o Temp CO issued January 22

# 9. Peterson Annexation (south of Inwood Street, west of 110th Avenue (North Y Street) and east of County Highway R-63)

# **STATUS: Awaiting Submittal**

- Application for annexation was received on February 25, 2020
- o The Board of Trustees reviewed the request at its April 14, 2020 meeting
- The Planning and Zoning Commission reviewed the request at its April 21, 2020 meeting and recommended approval of the request
- The City Council approved the annexation on June 1, 2020
- The City Council approved an ordinance establishing a zoning district on August 3, 2020

# 10. Cabin Coffee (910 East 2<sup>nd</sup> Avenue)

## **STATUS: Construction**

- o Sale of D&D lot and development agreement was approved by Council on October 21, 2019
- o Developer closed on the property on November 22, 2019
- o Council approved a 90-day on construction begin date extension at its May 18, 2020 meeting
- Council approved an alternate site plan on September 21, 2020
- Site plan approved on October 5, 2020
- o Building Permit issued on November 11, 2020
- Site work has begun

# 11. Crow's Nest Campground (Northwest Corner of South Jefferson Way and East 17th Avenue)

#### **STATUS: Construction**

- Staff held a preapplication meeting on a proposed campground on October 3, 2019
- The City Council approved a rezoning at its January 21, 2020 meeting
- The City Council approved a plat of survey at its May 4, 2020 meeting
- o The City Council approved an additional rezoning on June 1, 2020
- Development Agreement signed by property owner on August 27, 2020
- Site Plan approved on September 10, 2020
- Site work has begun

## 12. Williams Land

## **Status: Review**

- Located on land northeast of the intersection of South 15<sup>th</sup> Street and East Plainview Avenue
- Planning and Zoning Commission reviewed a rezoning request at its meeting on May 11
- City Council will hold public hearing on June 7

## 13. Fox Run 2

## **Status: Review**

- Located north of the intersection of North 7<sup>th</sup> Court and East Lincoln Avenue and east of the intersection of North 7<sup>th</sup> Street and East Norwood Avenue
- Preliminary plat received on April 23
- Review comments returned on May 10
- o Planning and Zoning Commission reviewed preliminary plat at its meeting on May 11

## 14. Heritage Hills 11

## **Status: Review**

- Located north of the intersection of North G Street and West Orchard Avenue
- Preliminary plat received on April 16
- o Review comments returned on May 4
- o Revised preliminary plat received on May 11
- Planning and Zoning Commission reviewed preliminary plat at its meeting on May 11
- City Council will review preliminary plat at its June 7 meeting.

## 15. Prairie Glynn Plat 3

#### **STATUS: Review**

- o Located southeast of the intersection of North 15<sup>th</sup> Street and East Iowa Avenue
- o Preliminary plat received on October 20, 2020
- Updated preliminary plat and stormwater management plan submitted on January 25
- o Review comments returned on February 4
- Construction documents submitted on February 23
- Updated preliminary plat and stormwater management plan submitted on April 13
- o Construction documents comments returned on April 23
- o Updated construction documents submitted on April 27
- o Planning and Zoning Commission reviewed preliminary plat at its meeting on May 11
- City Council approved preliminary plat at its meeting on May 17

#### 16. Ashton Park Plat 7

#### **STATUS: Construction**

- Located east of the intersections of East Euclid Avenue and North 18<sup>th</sup> Street and East Boston Avenue and North 18<sup>th</sup> Street
- City Council approved the preliminary plat at its May 18, 2020 meeting
- Revised preliminary plat submitted on July 6, 2020
- Construction Documents approved on September 10, 2020
- Site work has begun
- Final Plat submitted on February 17
- Planning and Zoning Commission recommended final plat for approval on March 9

## 17. Summercrest

#### **STATUS: Construction**

- o Located north of the intersection of North 7<sup>th</sup> Street and East Hillcrest Avenue
- o The City Council approved the Rezoning/PRD plan and preliminary plat on July 6, 2020
- Construction documents approved on September 25, 2020
