MECHANICAL PERMIT APPLICATION

- **IT IS THE RESPONSIBILITY OF THE PERMITEE TO CALL FOR THE REQUIRED INSPECTIONS AT 515-961-9430**
- Payment for e-mailed permits will be collected via phone call by customer service representative upon receipt of application.
- No mechanical work shall be concealed or covered until approved by the inspector. Work that is not tagged with an approval shall be considered unapproved. **ALL WORK MUST BE INSPECTED.**
- All portions of this form shall be completed by the applicant. Stamped signatures will not be accepted.
- Commencing work prior to obtaining a permit is subject to penalties.
- A mechanical permit shall expire if work is not commenced within 180 days or if work is abandoned for 180 days.
- Permits are nontransferable – all work shall be performed by permittee or permittee's employee.
- The permittee is expected to be knowledgeable of the Mechanical Code-any questions should be resolved prior to installation.
- Any digging or excavation requires you to contact Iowa One Call at 1-800-292-8989
