

FY21 General Fund Revenue Review







FY21 General Fund Revenue Review-Sources With Largest Deficit

- Property Tax Backfill
 - One-Time Expense for Architectural Services
 - Proposals Under Budgeted Amount
- Gas Utility Franchise Fee
 - Targeted for Street Capital Projects
 - Fluctuates on Weather-Just Starting Winter
- Use of Money and Property
 - Interest on Bank Accounts
- Charges for Service
 - EMS Activity in Spring Down
 - Park/Rec and Library Fees
- Private Grants
 - Anticipated
 - Minor Portion of Operating


